Key achievements and activities:

- Drafting, championing and implementing the University's Internationalisation Strategy, 2008-2015.
- Introduction and oversight of the Victoria International Leadership Programme—an award-winning internationalisation initiative which continues to attract over 1500 registrants annually.
- Expansion of Victoria's student exchange programme to offer students the widest range of partner university options in New Zealand, with an increase of 300% in annual outgoing student numbers from 2006 to 2016.

- Leadership of a highly successful international team which received excellence awards from Education New Zealand in all categories of awards offered (Student Support, International Marketing and Innovation in International Programming).
- Successful leadership in 2012 of negotiations to set up the New Zealand Universities Accounting Pathway Programme in Malaysia—a programme involving three New Zealand universities and a Malaysian partner to provide partial in-country training (using VUW curricula and moderators) for students who then transfer to New Zealand for completion of accounting degrees. This multi-million-dollar programme has delivered annual cohorts of approximately 150 Malaysian students to the New Zealand consortium universities since 2015.
- Conceptualisation of Victoria’s “Understanding Southeast Asia” field course and securing of funding for two successive years (2014 and 2015) of \$325,000 from the Prime Minister’s Scholarships for Asia and from Education New Zealand. This funding enabled two cohorts of 25 New Zealand students (mainly from Victoria but also from other universities) to spend 5 weeks of intensive study in seven Southeast Asian countries.
- A sustained record of public contribution nationally, expressed primarily through service to the New Zealand Institute of International Affairs (since 2009 as National Vice-President).
- A sustained record of public contribution internationally, as exemplified by medals for services to the Vietnamese and Polish Governments and by invited membership of the International Advisory Board of the Universidad de Monterrey in Mexico.

Examples include: negotiation of funding from the Vietnamese and New Zealand governments to deliver VUW’s Master of International Relations through the Diplomatic Academy of Vietnam (DAV) to Vietnamese officials using mixed-mode delivery teaching in Hanoi and Wellington; securing of a PhD Scholarship funding agreement with the Directorate of Higher Education of Indonesia (DIKTI); and the negotiation of an agreement which enabled VUW to become the only New Zealand university to have a double Masters’ degree with Peking University (Master of International Relations/Master of Public Policy).
