# **Name of course:** THEORY AND PRACTICE OF INTERNATIONAL RELATIONS AND FOREIGN POLICY IN LATIN AMERICA AND THE CARIBBEAN

#### Short description:

Course dedicated mainly to second cycle students in English in the following fields: Postgraduate Program in International Relations and Postgraduate Program in Political Science. The objective of the course is to increase the practical skills of students and apply the theory of International Relations in the analysis of foreign policy in the case of Latin America and the Caribbean.

The course will take place in the form of a seminar. During the classes, individual case studies will be carried out using theoretical perspectives and methodologies typical of International Relations and Foreign Policy.

#### **Full Course Description:**

The objective is to understand the main framework of theories of International Relations 'discipline in order to explain Foreign Policy as a part of it.

The course will give an approach to the main processes of development of international relations and foreign policy in the Latin American and Caribbean region with the use of the main theories of International Relations. It will be given through an approach to theoretical foreign policy analysis as part of the ground of International Relations, main authors and literature about it. Then studying the principal approaches about Foreign Policy analysis, conceptualization and the methodological proposals.

The integration processes in Latin America and the Caribbean, the dynamics of international relations and the main economic and political challenges; the United States' strategy towards Latin America, and the strategies of the European Union and emerging powers (including China) vis-à-vis Latin America.

### Tittle of courses

- 1. Introduction.
- 2. International Relations theory and the theoretical foreign policy analysis as a part of it, principal authors (Rossenau, Merle, Hoffman, Calduch, Seminatore, Hudson, etc.) and a review of the literature of the field.
- 3. Main approaches of Foreign Policy analysis, conceptualization, and the principal aspects of methodological proposals to the analysis of Foreign Policy: actors, factors (internal and external), decision making process, national character, power, national interest, delimitation of objectives, strategy, and evaluation, among the most important.
- 4. Analysis of the foreign policy of the main states of the region (including Brazil, Argentina and Mexico).
- 5. Analysis of the foreign policy of the smallest states of Latin America and the Caribbean.
- 6. The integration processes in Latin America and the Caribbean (Latin American Integration Association, Central America Integration, Caribbean Association) and the political organisms (CELAC, CEPAL, OEA) and their impact on the foreign policy of the States.

- 7. The United States' strategy towards Latin America and the importance of the relationship with the great power.
- 8. The strategies of the European Union and emerging powers (including China) vis-à-vis Latin America.

Literature (detailed course desription and literature will be given during lectures)

- The first assignment in-class presentation of research proposals for the analytical paper (20%);
- The second assignment an analytical paper (2,800 3,500 words) will count for 70% of the final grade.

- **4) Teaching Method:** The course will take place in a seminary mode, but students will participate using the given bibliography. There will also be interactive discussions at the end of each class.

of a Latin America or Caribbean State using an International Relations theory (3,000-word length).
