IMPORTANT NOTES FOR THE STUDY PROGRAMME:

Students must earn credits in BHP-OSH Occupational Safety and Care and Introduction to the International Protection of Intellectual Property in the 1st semester of the 1st year of the Programme unless they are able to provide the confirmation of the learning outcomes of these courses.

In the course of the programme students must earn 5 ECTS for courses (electives offered by the University - OGUN) taught in humanities.

* ECTS for General Elective Courses and elective courses from the offer of the Faculty of Political Science and International Studies must be proved at the end of the particular academic study year (aggregate for both terms). 4 ECTS for General Elective Courses may be exchanged for Internship. The Internship will not be offered by the Programme - its choice is at the Students discretion. The Internship must have at least 120 hours. Before taking up the Internship, the Student must obtain formal approval. Upon completion of the Internship, the Student must submit: Internship Report, Official certificate indicating number of hours, tasks and grade.
